SPP extended to 25 March 2019 following strong demand from eligible shareholders

BlackEarth Minerals NL (ASX: BEM) ("BlackEarth", the "Company") announced on 21 February 2019 a Share Purchase Plan (SPP) which allows existing eligible holders of fully paid ordinary shares in the Company to apply for up to A\$14,999.95 of shares at an issue price of \$0.066 per share.

The SPP will involve the issue of up to 18,235,650 new fully paid ordinary shares at an issue price of \$0.066 per share to raise gross proceeds of up to approximately \$1.2m.

The decision to extend the SPP closing date to 5.00pm (WST) on Monday 25 March 2019 follows strong support for the SPP from eligible shareholders after the Company's recent announcements regarding significant trenching results at both its Maniry and lanapera graphite projects.
