Notice under section 708A(5)(e) of the Corporations Act

This notice is given by Northern Minerals Limited (ASX: NTU) (**Company**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company has issued the following:

- 1) 50,000,000 fully paid ordinary shares in the Company under a private placement to various sophisticated investors; and
- 4,100,000 fully paid ordinary shares in the Company as a result of the exercise of performance rights; together (the **New Shares**).
