CEO Appointment and Board Changes

Marcus will remain as an Executive Director of FEIG and its wholly owned NZ subsidiary FE Investments Limited (FE Investments).

As a part of this succession and transition planning the Company would also like to announce the following changes effective immediately:

Mr TK Shim will step down as Group CEO and as a Director of FE Investments but will continue as a Director of FEIG. Mr Shim will assist with the smooth transition of the incoming CEO and continue to assist the Company with the management of its property loan portfolio and other special projects.

Mr Melvin Stewart – will step down as an Executive Director of both FEIG and FE Investments. Mr Stewart will continue to assist the Company with the management of its property loan portfolio.

The Board would like to thank the founders TK Shim and Melvin Stewart for their dedication and commitment over the last 16 years for building a successful business which has provided a distinguished financial platform to our customers and employees.
