Issue of Securities and Notice Under Section 708A

18th April 2019

Rumble Resources Limited (Company) (ASX: RTR) hereby notifies the ASX under section 708A(5)(e) of the Corporations Act 2001 ("the Act") that the Company has today issued 25,814,645 fully paid ordinary shares ("Shares") and 3,473,110 unlisted options (each with an exercise price of \$0.15 and an expiry date of 22 December 2019) to professional and sophisticated investors under its existing placement capacity under ASX Listing Rule 7.1 and ASX Listing Rule 7.1A. Refer to the ASX announcement dated 15 April 2019 for details in respect to the placement ("Placement"). The Company notes that following its announcement on 15 April 2019 an additional 500,000 Shares and 215,100 unlisted options have been issued as part of the Placement.

The 2,181,812 Shares and 242,000 unlisted options remaining to be issued under the Placement are proposed to be issued to directors of the Company and will be subject to shareholder approval. A notice of meeting will be despatched shortly to approve, amongst other resolutions, the ratification of the Placement and the issue of the additional securities to the directors of the Company.

An Appendix 3B is enclosed with this announcement.

The Company gives this notice pursuant to Section 708A(5)(e) of the *Corporations Act 2001* (Cth) ("Corporations Act").

1. The Shares were issued without disclosure to investors under Part 6D.2, in reliance on and providing notice under Section 708A(5) of the Corporations Act.
2. The Company, as at the date of this notice, has complied with:
 - a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - b) Section 674 of the Corporations Act.
3. As at the date of this notice, there is no information, for the purposes of section 708A(7) and 708A(8):
 - a) that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
 - b) that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
