Current Status of the Company

The affairs, business and property of the Company are being managed by the Joint Administrators, Stephen Grant and Anthony Cork, who act as agents of the Company and without personal liability.

The Company finds itself at an insolvent position due to guarantees given to a secured lender group in respect of borrowings in subsidiary companies. The Joint Administrators will attempt to agree a restructuring of the liabilities of the company so that the company can be released from the existing debt guarantees to enable the company to relist on the ASX on a restructured basis.
