Board and Executive Update

Joyce Corporation Limited is pleased to announce the next stage in the Plan to be a \$100m company by 2023. The Company will be appointing a full time CEO and implementing a staged Board renewal program.

The Board will be undertaking a formal selection process for the appointment of the full time CEO. Anthony Mankarios who has been filling the role of Executive Director in the absence of a CEO will be stepping down from this executive role as at 30 June 2019. Keith Smith, Chief Operating Officer/Finance Executive, will be acting CEO until a formal CEO appointment is made.
