Pearl Global Limited (the Company) (ASX: PG1) advises that with the approvals provided by shareholders at the meeting held 7 June 2019, the following issues of securities have been made:

- 39,370,078 shares and 19,685,039 unlisted options exercisable at 24 cents each expiring 12 June 2020 raising \$5,000,000 to Perpetual Corporate Trust Limited pursuant to the placement agreement with ROC Asset Management Pty Ltd; and
- 666,666 shares and 333,333 unlisted options exercisable at 23 cents each expiring 27 February 2020 to Bretnall Custodians Pty Limited as repayment of an unsecured loan of \$100,000.
