

Completion of Share Purchase Plan

Sydney, Australia, 24 June 2019 - Further to the Announcement dated 18 June 2019, Splitit Payments Ltd. (ASX:SPT), a leading global monthly instalment payments solution business, confirms the completion of the issue and allotment of the new fully paid ordinary shares (New Shares) under the share purchase plan (SPP).

Splitit has today issued to SPP participants 377,500 New Shares at \$0.80 per New Share (being the same price as those shares issued to institutional and sophisticated investors under the placement completed on 24 May 2019 (Placement)), raising \$302,000.

The total amount raised under the Placement and the SPP Offer is approximately \$30.3 million. The proceeds will enable Splitit to increase its capacity to meet the current excess demand for its products, pursue its growth strategy at a faster rate than was anticipated in its IPO prospectus, and allow it to capitalise on existing and new opportunities as they arise.

Splitit is a payment method solution enabling customers to pay for purchases with an existing debit or credit card by splitting the cost into interest and fee-free monthly payments, without the need for additional registrations or applications.
