I refer to the appointment of Daniel Bredenkamp and I as Joint and Several Administrators of the Company on 12 June 2019 and provide the below update to shareholders on the matters which have been attended to since our appointment.

FUNDING AGREEMENT

The Administrators have entered into a funding agreement with the Company's largest shareholder, Noble Resources Ltd (Noble). Pursuant to the funding agreement, Noble have advanced funds to enable the Company to meet its ongoing operational expenses (including those expenses being incurred by the Imperial Joint Venture in Nigeria) for a four-week period, whilst the Administrators assess all options available to the Company moving forward.

EXPRESSIONS OF INTEREST SOUGHT

The Administrators are seeking expressions of interest from parties interested in acquiring all or part of the Company's assets (being its interest in the Imperial and Tawny joint venture projects) or in submitting a proposal for the recapitalisation and restructure of the Company.

The first meeting of creditors of the Company was held on Monday, 24 June 2019. At the meeting, creditors ratified the appointment of the Administrators and elected to appoint a Committee of Inspection.
