NANOLLOSE APPOINTS UK BASED PRODUCT DEVELOPMENT AND COMMERCIALISATION EXPERT TO THE BOARD

Nanollose Limited (ASX:NC6) ("Nanollose" or the "Company") is pleased to announce the appointment of independent non-executive director Heidi Beatty to the board of Nanollose. Ms Beatty has 20 years' experience developing consumer and healthcare products and is the founder of Crown Abbey, an innovation consultancy company operating in the US and Europe that helps consumer and healthcare clients identify new technologies and then supports them through to launch.

After gaining a bachelor's degree in Chemistry from the University of York, UK, Heidi worked with Johnson & Johnson for 10 years across Europe and the US, initially developing skin products for Johnson's Baby® and then went on to develop a number of nonwoven based women's health and wellbeing products. She has held R&D leadership roles in subsequent companies, including PDI Healthcare Inc.

In addition to setting up her own company and numerous product launches, Heidi holds a Project Management Professional (PMP) certification and a Black Belt in Six Sigma. She has also been the Chair of the Wet Wipes Committee at the European Disposables and Nonwovens Association (EDANA) for 3 years, and currently has active roles on several of their committees.

Not only does she bring considerable technical expertise and an in-depth commercial knowledge of the nonwovens and hygiene markets, but she also brings enthusiasm and passion for the Nanollose technologies. Ms Beatty's extensive experience in the area of nonwoven products is particularly valuable given the Company's recent announcement on 9 April of its successful pilot production of fibre specifically developed for nonwoven applications, a market worth US\$44b.

The Company also announces that executive director, inventor and founder, Gary Cass, is stepping down from the board, but will continue to focus on the development and commercialisation of the Nanollose technologies for textiles and other applications in his ongoing executive role as Chief Scientific Officer.

This restructure of the Board enhances the diversity and independence of the Board.
