He has also worked previously for BHP Steel and BHP Engineering – Mining Services, Arimco Mining Pty Ltd and RGC Thalanga. Mr Grace's qualifications include a Bachelor of Applied Science (Geology) from Queensland University of Technology; a Bachelor of Science (Honours) from James Cook University; and a Master of Mining Engineering from the University of New South Wales.
