FINANCIAL REPORTS and AGM - UPDATE

Following the announcement dated 31 May 2019, the Board of Kresta Holdings Limited (**Company**) (ASX:KRS) advises that there will be further short delay to the finalisation of the audit of its financial reports for the financial year ended 31 December 2018.

The delay is due to the recent appointment of the Company's new auditor, Mazars Risk & Assurance Pty Ltd. While the Company had anticipated that the audit would be finalised to allow for the release of the financial reports by 31 July 2019, the steps taken to ensure the thoroughness of the audit process have caused a further delay.

It is now anticipated that the financial reports will be released by 30 August 2019, with the Company's 2019 Annual General Meeting to be held by 30 September 2019.

The Company is working with the auditor to complete the review as soon as possible.

The Company also advises that Ms Wen Qian has resigned as an executive director of the Company.

The Company also advises that Mr Mingming Zhang has resigned as Company Secretary. Tao Li has been appointed as the new Company Secretary. Mrs Li has been the Company's Group Financial Controller since 2 January 2019.
