Changes in Mining Contractor arrangements

Ikwezi Mining Limited (ASX: IKW, Ikwezi Mining or Company).

Termination of Current Mining Contractor

Ikwezi Mining Ltd's (the "Company") South African subsidiary, Ikwezi Mining (Pty) Ltd (the "Subsidiary") enlisted the services of CML Melger Mining (Pty) Ltd ("CML"), a contract mining company to undertake opencast mining in the Central Mini Pit in respect of the Mining Right held by the Subsidiary on the 25th of April 2018. At the request of CML, the contractual agreement for undertaking of opencast mining in the Central Mini Pit has since been terminated, with the effective date for such termination being the 31st of July 2019.

Appointment of New Mining Contractor

Pursuant to the above, the Subsidiary has decided to enlist the services of another mining contractor for continuation of the opencast mining in the Central Mini Pit. Ikwezi has appointed Stefanutti Stocks Mining Services ("SSMS"), a division of Stefanutti Stocks (Pty) Ltd, a company that is listed on the Johannesburg Stock Exchange. The new Contractor will commence with mining operations at the Central Mini Pit with effect from the 1st of August 2019.

Stefanutti & Bressan was established in 1971 and rebranded to Stefanutti Stocks with its acquisition of the Building Division of Stocks and Stocks and its listing on the JSE during 2007/2008. During this period, Stefanutti Stocks expanded its services to include a Mining Services offering to the market, when it acquired Environmental, Civil and Mining Projects (ECMP). ECMP was established in 1991and it provided mining services inclusive of open pit contract mining to the mining industry. ECMP was incorporated into Stefanutti Stocks as its Mining Services Division (SSMS).
