# **QUARTERLY REPORT FOR THE PERIOD ENDING 30 JUNE 2019**

The Board of Syngas Limited ("Syngas" or "Company") hereby presents the June 2019 Quarterly Report.

## **Corporate Transaction and Future Direction**

The Board is currently evaluating a restructuring and acquisition of a prospective gold project to enable the Company to comply with Chapters 1 & 2 of the ASX Listing Rules. In addition, the Company has also appointed a corporate advisor based in Perth to identify suitable projects and to restructure the Company for the same purpose. The Company will make the necessary announcement when a more definitive proposal is finalised and after consultation with the ASX.

## **Finance**

During the Quarter the Company continues to rely on the loan facility provided by Mr Low Siak Wei, a director of the Company, which as at 30 June 2019 was drawn down to the amount of A\$700,000. In addition, the Company also has 2 unsecured loan facilities with AsiaPacific Businesslink Sdn Bhd, a company related to Mr Low Siak Wei totalling A\$750,000. As at 30 June 2019, the total amount drawndown from the loan facilities was A\$375,000.
