New Zealand Coastal Seafoods Limited – (ASX: NZS) – Formerly XTV Networks Ltd – Anticipated Reinstatement to Official Quotation

Description

The securities of New Zealand Coastal Seafoods Limited ('NZS') are expected to be reinstated to Official Quotation at the commencement of trading on Monday, 5 August 2019, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. NZS raised \$5,000,000 pursuant to the offer under its prospectus dated 24 May 2019 ('Prospectus') by the issue of 200,000,000 shares at an issue price of \$0.025 per share.
