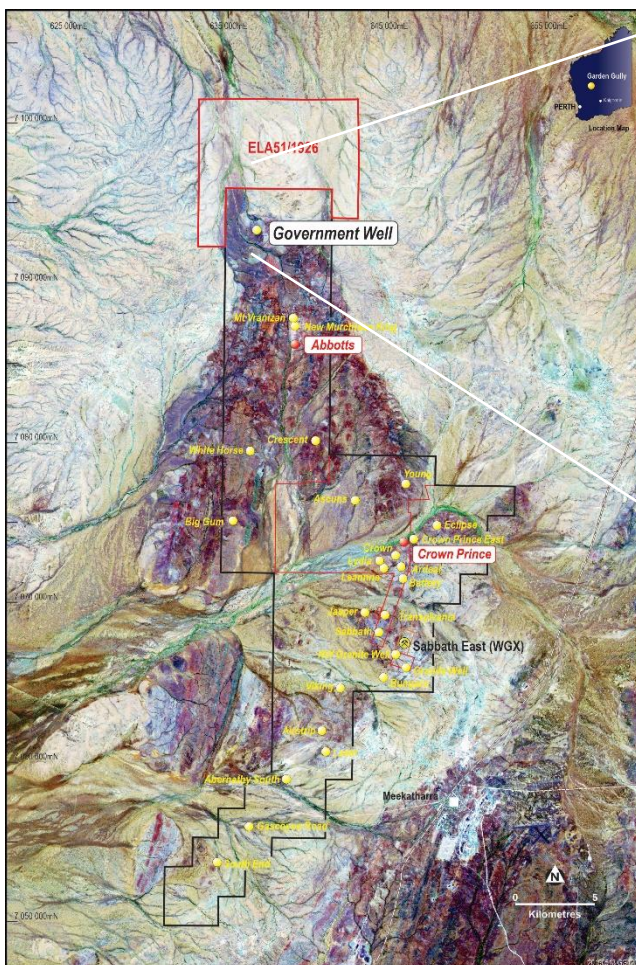


**ABBOTTS GOVERNMENT WELL EM SURVEY**

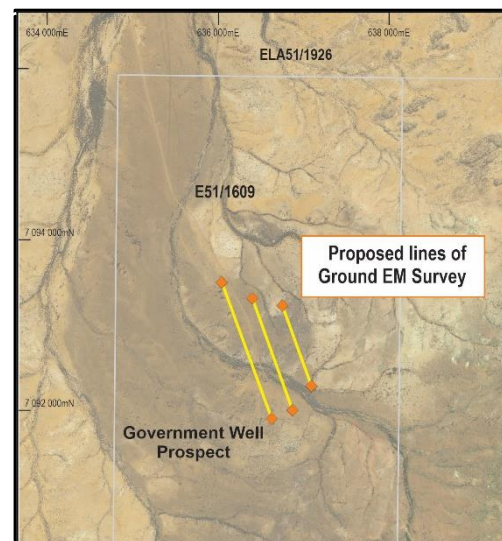
Ora Gold Limited (ASX: OAU) (**Ora Gold**) is pleased to announce the commencement of an EM survey over the Government Well copper-silver-gold prospect located five kilometres to the north of the Abbots gold deposit (Figure 1).

An earlier release (OAU: 27 June 2019) advised the results of an initial rock sampling program over the Government Well area (on E51/1609), which returned high grade copper and silver assays along with moderate gold results. Copper assays of up to 19.5% were associated with silver assays up to 275.5g/t and over 1g/t gold. The rock samples were collected from the walls of several small pits which have exposed oxidised base metal material that has been identified as milled breccia.

The Government Well EM survey (Figure 2) is being conducted by Southern Geoscience Consultants and is expected to be finished and results reported within two weeks.

**About Government Well Prospect**

The prospect is located at the northern extremity of the Abbots greenstone belt on the wholly-owned E51/1609 tenement. Local geology includes typical greenstone belt lithology with black shale horizons and felsic and mafic/ultramafic rocks. A late stage Archaean porphyry has intruded the package approximately 800 metres from the prospect. Historical exploration for base metal mineralisation in the Abbots area has not been comprehensive.

**Garden Gully and Abbots Tenements**

The Company's 100% owned Garden Gully and Abbots tenements cover the majority of the Abbots Greenstone Belt and comprise 2 granted Mining Leases, 21 granted Prospecting Licences and 7 granted Exploration Licences covering about 393 square kilometres, not including the recent Exploration Licence application. The tenements are located in Western Australia's Murchison region about 20 kilometres north-west of the town of Meekatharra.

**About Ora Gold Limited**

The Company is an ASX-listed company exploring and conducting pre-production activities on its Abbots and Garden Gully tenements near Meekatharra, Western Australia. The near-term focus is of low-cost development of its already identified shallow mineralisation, while investigating the potential extensions for larger deposits.
