Cleansing Notice - NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS Act

Adriatic Metals plc ("Adriatic" or "the Company"), confirms that on 9 August 2019 it completed the issue of 500,000 Chess Depository Interests (CDI) in the capital of the Company. The CDIs were allotted at \$0.40 per CDI and pursuant to the exercise of \$0.40 priced options.

The Company gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act) that:
