The initial term of the Agreement is for one year which can be rolled over. Standard termination clauses exist on both sides.

Since 2000, Intelligent Home have completed over 50,000 installations in Perth, making them one of the largest smart wiring, home and building technology providers in Australia. They currently work with 8 of the 10 largest builders in Western Australia. Intelligent Home Director Brenton Morris and General Manager Paul Turnor are dedicated to designing and delivering streamlined, intuitive and easy-to-use home technology solutions. Mr Morris and Mr Turnor lead a team of over 100 experts with a proven track record of strong sales and long-term client relationships.

The Agreement with Intelligent Home, coupled with the previously announced agreements with Powerhouse Home Automation and Limitless Automation Pty Ltd, result in the Company now having three distributors actively selling Quantify's products in Western Australia. Quantify is focused on signing up leading distributors across Australia to capture a significant



proportion of the \$1.8B pa market that is growing at 30% pa¹. Arrangements with distributors in the other states are expected to be announced shortly.

We enjoy being able to offer clients the flexibility to expand or reconfigure their system as their needs change, without re-wiring their home. We wanted to partner with Quantify because they offer world-leading smart home automation technology, which we also see it as being highly applicable to the NDIS and Aged Care markets."
