



## Secondary Trading Notice - 708A(5)

Winchester Energy Limited (**Winchester** or **Company**) announced on 7 August 2019 that the Company was undertaking a placement of shares to raise approximately \$2.5m. The Company advises that it has issued 83,900,000 in a first tranche of cleared funds to raise \$2,097,500. The Shares were issued to sophisticated and professional shareholders at \$0.025 cents each and raised \$2,097,500 before costs.

The Company anticipates that it will issue a second tranche of up to 23,936,463 Shares to complete the placement, to professional and sophisticated investors to raise a further \$ 598,411 before costs shortly.

An Appendix 3B is attached to this notice detailing the issues. The disclosure required under LR 3.10.5A will follow on completion of Placement.

## Secondary Trading Exemption

The Corporations Act 2001 ("**Act**") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.
