APPOINTMENT OF DR YA-QIN ZHANG TO THE FORTESCUE BOARD OF DIRECTORS

He currently serves on the Board of Stewardship for the Future of Mobility of the Davos World Economic Forum and Chairman of the Apollo Alliance, the largest open platform for autonomous driving in the world.

Fortescue's Founder and Chairman Mr Andrew Forrest AO welcomed Dr Zhang to Fortescue's Board.

"We are now entering a period in which our world is changing at a pace that is unprecedented in global history. Against this backdrop, it is very clear that artificial intelligence, including autonomy, will undoubtedly be one of the greatest industrial revolutions of our time," Mr Forrest said.
