Notice under section 708A(5)(e) of the Corporations Act


This notice is given by Northern Minerals Limited (ASX: NTU) (**Company**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company issued a total of 49,372,049 fully paid ordinary shares in the Company on 5 September 2019 as a result of an issue of shares to investors under the \$30 million placement announced on 22 July 2019, the exercise of performance rights and an issue of shares under a private placement announced on 5 September 2019 (the **New Shares**).

In accordance with section 708A(6) of the Corporations Act, the Company advises that:

- a) the New Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- b) this notice is being given under section 708A(5)(e) of the Corporations Act;
