

Drilling Commenced – Gordons Gold Project

Yandal Resources Ltd (ASX: YRL, "Yandal Resources" or the "Company") is pleased to announce drilling has commenced at the Gordons gold project located in the highly prospective Kalgoorlie-Boulder Region of Western Australia.




Figure 1 – Gordons Dam gold prospect lithology interpretation, SAM exploration target areas, newly interpreted structures with historic and proposed drill collar locations.

At the Gordons Dam prospect, a 27 hole combination Air-core ("AC") and reverse circulation ("RC") drilling program, totalling ~1,800m, will test for extensions to primary gold mineralisation intersected in earlier programs¹, and provide first pass exploration over priority Sub Audio Magnetic geophysical ("SAM") targets south along strike (Figure 1)².




Figure 2 - Location map of the Gordons gold project.

In addition, two slim line RC holes for 120m are planned to test beneath anomalous rock chip samples at the Lady Clara and Dickens Custer prospects and two AC holes for 120m to test geochemical targets ~300m west of the Gordons Dam prospect (Figure 2).

Results and follow-up exploration plans are expected to be available in the December Quarter.
