SHARE PURCHASE PLAN TO ADVANCE PROJECTS

Barra Resources Limited (ASX Code: BAR) is pleased to announce a \$1,250,000 Share Purchase Plan (SPP). The funds will go towards our Coolgardie Gold Projects, the Mt Thirsty Cobalt-Nickel project and for working capital.

Specifically, in the short term, Barra will use the funds to deliver the 5,000m RC drilling program to extend the Mineral Resource at Main Lode, within the 100% owned Burbanks Gold Project at Coolgardie, and build on the positive Scoping Study recently announced to the market. On the Cobalt-Nickel front, the funds will be used to complete the Pre-Feasibility Study on the 50% owned Mt Thirsty Cobalt Nickel Project at Norseman.

The SPP will afford shareholders at the record date of 23 September 2019 the opportunity to acquire from \$1,000 (minimum) to \$30,000 (maximum) worth of Barra shares each at the issue price of 2 cents per share. This represents a 17% discount to the last trading price and a 13% discount to the 5 day volume weighted average trading price of Barra shares.

The Directors view the SPP as a means of allowing shareholders to participate in the current capital raising at a modest price and with strong growth prospects.

The SPP will be limited to a maximum of \$1,250,000. The Directors reserve the right to accept oversubscriptions.
