F	PRINCIPLE 1: LAY SOLID FOUNDATIONS FOR MANAGEMENT AND OVERSIGHT

In view of the size and resources available to the Company, it is not considered that a separate nomination committee is warranted.

The Board evaluates the mix of skills, experience and diversity at the Board level. The Board believes that a highly credentialed Board, with a diversity of background, skills and perspectives, will be effective in supporting and enabling delivery of good governance for the Company and value for the Company's shareholders. The mix of skills comprised in the current Board, and that the Board would look to maintain, and to build on, includes:

The Executive Chairman and the Chief Financial Officer make this assurance to the board.
4.3	A listed entity that has an AGM should ensure that its external auditor attends its AGM and is a available to answer questions from security holders relevant to the audit.	The Board requests that Nexia, the Company's external auditor, attends the Annual General Meeting of the Company and is available to answer shareholder questions relating to the audit of the Company's financial statements, preparation and content of the auditor's report, the accounting policies adopted by the Company and auditor independence.
