BLACKHAM ANNUAL RESOURCES AND RESERVES UPDATE

Highlights

- Total resource now 93Mt @ 2.1g/t for 6.4Moz
- 57% of resource in measured and indicated categories.
- Total reserve now 25Mt @ 1.7g/t for 1.4Moz.
- Williamson resource updates ensure a robust mine plan for the main ore source through 2020.
- Further updates on sulphide resources and reserves anticipated in the December quarter to further de-risk the Stage 1 Sulphides Expansion Project.

Blackham Resources Ltd (**ASX: BLK**) ("**Blackham**") is pleased to provide updated Mineral Resource and Ore Reserve Estimates (MRRE) for the Wiluna, Williamson and Matilda mining centres at the Wiluna Gold Operation as at 30th June 2019.

The 2019 MRRE presented in Tables 1 & 2 reflects updated resource models for Wiluna and Williamson deposits, open pit mining depletions, and updated underground resource models for the Bulletin, Essex and Golden Age deposits.

Open pit mining at the Matilda and Wiluna centres is expected to be completed during 2020, with open pit operations now ramping up at Williamson. An updated resource model for Williamson has been completed with pre-production activities at the Williamson pit having commenced in advance of ore production scheduled from November 2019. Williamson is expected to provide the baseload of free milling ore for throughout 2020.

Resource definition and mining studies are well advanced for Blackham's transition to Stage 1 of its Sulphide Expansion Project, with underground mine planning and optimisation now nearing completion in conjunction with the engineering design for the sulphide flotation plant. A major MRRE update is anticipated at the completion of this work, expected in the December quarter.

Blackham's Executive Chairman, Mr Milan Jerkovic said *"Our latest resources and reserves update reflects our work to strengthen resources and reserves in support of a robust mine plan moving forward, and mining depletion during the 2019 financial year. Blackham is focussed on its Stage 1 Sulphides Expansion Project and further updates to resources and reserves are expected in the coming quarter as sulphide mine optimisation studies are nearing completion."*




Figure 1. Resource comparison from 2018 to 2019.

The change in resources from 2018 to 2019 (Figure 1) is predominantly as a result of reporting from a \$2,400 optimised pit shell compared to the \$1,800 shell in 2018. This has resulted in an increase in open pit resources for Wiluna and a decrease in the underground resources as the latter are reported below the shell. Other changes include updated underground models for Bulletin, Essex and Golden Age and mining depletions for the free milling portion of the Wiluna and Matilda deposits. These factors in conjunction with the mining depletions have resulted in a reduction in total ounces of less than 5%.

The Williamson deposit also has been reported from a \$2,400 pit shell for the first time which has reduced the total reportable resource compared to 2018 when open pit resources were reported above the -200m relative level (defined as less than 200m below surface).

Open pit mineral resources are quoted within an optimised pit shell rather than above a particular relative level, to reflect the application of mining parameters and the gold price and quote the portion of mineralisation that has reasonable prospects of eventual economic extraction. For the Wiluna open pits (excluding the Adelaide / Moonlight Shear area) and Williamson an optimised pit shell of \$2,400 was used for reporting. For the Adelaide / Moonlight Shear, deposits continue to be reported in the smaller \$1,800 shell as no further work has been completed.

Cube Consulting were engaged to produce the updated gold grade estimate for the Wiluna and Williamson mineral resources based on interpretations completed by Blackham geologists. The mineral resource was peer reviewed and classified with guidance from Cube.

Underground sulphide resources at Wiluna for Essex and Bulletin have also been updated from 2018, with further updates on sulphide resources and reserves anticipated in the December quarter to further de-risk the Stage 1 Sulphides Expansion Project.

Ore reserves have been depleted for mining during the 2019 financial year, and updated operational costs, as well as updated geotechnical, dilution, recovery and cut-off grade parameters. Open pit reserves are now estimated using a gold price of \$2,000/oz, whereas the 2018 reserves update used a gold price of \$1,650/oz. Wiluna underground and Wiltails reserves have not changed since the last update.

Mineral Resource Estimate

Wiluna and Matilda Gold Deposits Mineral Resource Commentary

Summary

The Wiluna and Matilda gold deposits are located within the Wiluna Goldfield, close to the town of Wiluna at latitude 26°38'S, longitude 120°15'E on the Wiluna (SG 51-9) 1:250 000 scale map. Perth, the nearest capital city, lies 750km to the southeast.

The gold deposits are categorised as orogenic gold deposits, with similarities to many other gold deposits in the Yilgarn region. The deposits are hosted within the Wiluna Domain of the Wiluna Greenstone Belt. Rocks in the Wiluna Domain have experienced greenschist-facies regional metamorphism and brittle deformation. The Wiluna Domain is comprised of a sequence of foliated basalts and high-magnesium basalts, with intercalated felsic intrusions, lamprophyre dykes, metasediments, and dolerites.

Wiluna ores are typically oxide, refractory or free milling quartz mineralisation. The refractory ore has most gold occurring in either solid solution or as sub-microscopic particles within fine-grained sulphides. Mineralisation at Wiluna is principally controlled by the shear zones which have variable strike and dip orientations and typically flex along strike and down dip. These flexures in conjunction with favourable host rock composition act to form the best ore zones.

Estimation Methodology

The interpretation of the mineralisation was carried out using a methodical approach to ensure continuity of the geology and estimated mineral resource. For the open pit resources, a lower cut-off grade of 0.3g/t with a minimum mining width of 2m was applied.

Underground mineralisation was typically modelled to a 2.5g/t lower cut.

All available geological data was used in the interpretation including mapping, drilling, oxidation surfaces and interpretations of high-grade ore shoots. Only diamond and reverse circulation drilling samples were used in the final estimate however all available grade control data was used in the geological assessment.

The Wiluna dataset has been validated in Datashed and Surpac using internal validation macros and checks. Holes have been checked and corrected where necessary for:

- Intervals beyond EOH depth
- Overlapping intervals
- Missing intervals
- Holes with duplicate collar co-ordinates (i.e. same hole with different names)
- Missing dip / azimuth

- Holes missing assays
- Holes missing geology

Open pit resource estimation for Bulletin, Essex, Happy Jack, Squib, Starlight, East Lode, West Lode and the Adelaide/Moonlight Shear was completed using Localised Uniform Conditioning (LUC) for gold (Au). Block model field coding was used to constrain the estimate. All other open pit resources including Golden Age North were estimated using Ordinary Kriging (OK).

For the LUC models the Panel OK estimate for gold for each domain was implemented in Isatis using the search neighbourhood parameters defined by QKNA analysis. The Panel block estimation size used was 6mE x 15mN x 10mRL. The OK search and variogram rotations were varied locally using a set of guiding 'trend' surfaces to best mimic the interpreted orientation of the lodes. The final LUC model, after post-processing steps have been applied, has a user block 3mE by 5mN by 2.5mRL which relates to an SMU. No sub-blocking was applied. The OK open pit models used varying block sizes with a parent cell generally reflecting half the drill hole spacing while honouring the width and vertical extents of the lodes. The block size relates to an assumed selective mining unit (SMU).

All underground resource estimates used OK interpolation. Models used varying block sizes with a parent cell generally reflecting half the drill hole spacing while honouring the width and vertical extents of the lodes. The Panel block estimation size used for the updated Bulletin and Essex models were 5mE x 10mN x 10mRL and 15mE x 15mN x 10mRL respectively. Variography and estimation parameters were optimised using Supervisor software.

Topcuts were determined from statistical analysis. A number of factors were considered when determining the top-cuts including:

- The disintegration point of the data on the probability plots;
- Having a coefficient of variance (CV) under 2.0; and
- Reviewing the model (block) grades against the composites.

A range of criteria were considered when addressing the suitability of the classification boundaries to the resource estimate:

- Geological continuity and volume models;
- Drill spacing and available mining information;
- Modelling technique
- Estimation properties including search strategy, number of informing composites, average distance of composites from blocks, number of drill holes used and kriging quality parameters.
- For open pit resources a "skin" surrounding existing stope voids (equal to the volume of the voids) has been classified as inferred to highlight the associated mining risk.
- For underground resources a "sterilised" area around existing stope voids has been set as unclassified as it is expected that the mineralisation cannot be mined due to geotechnical considerations.

The classification of the blocks was also visually checked and adjusted to remove any "spotted dog" effects. No measured resources were calculated. Estimated blocks that have been informed by predominantly historical drilling where QA/QC data has not been reviewed were assigned as inferred.

Williamson Gold Deposit

Summary

Williamson gold deposit occurs within a north-south trending monzogranite and enveloping shear zone, with broad geological similarities to well-known major deposits in the region, such as Gruyere and Thunderbox.

The contacts of the Williamson monzogranite are strongly sheared and generally dip steeply east. Gold mineralisation is free-milling and occurs mainly with stockwork quartz veinlet arrays and disseminated pyrite within the monzogranite and along contacts with the dolerite and basalt host rocks. Higher-grade mineralisation and visible gold occur within grey sulphide-rich quartz veinlets along the sheared contacts of the monzogranite. Alteration ranges from weak carbonate-chlorite alteration distal to the main structure, to strong hematite-carbonate alteration associated with high-grade mineralisation. The deposits are covered by approximately 5m of barren lake sediments.




Figure 2. Williamson cross-section showing the mineralised monzogranite unit with the current pit design and the \$2400 reporting shell.

Estimation Methodology

The interpretation of the mineralisation was carried out using Leapfrog software with all available geological data used in the model including mapping, drilling, oxidation surfaces and interpretations of high-grade ore shoots. Only

diamond and reverse circulation drilling samples were used in the final resource estimate however all available grade control data was used in the geological assessment.

A lower cut-off grade of 0.3g/t with a minimum mining width of 2m was applied in the interpretation, this zone essentially captures the width of the monzogranite unit.

The Williamson dataset has been validated in Datashed and Surpac using internal validation macros and checks. Holes have been checked and corrected where necessary for:

- Intervals beyond EOH depth
- Overlapping intervals
- Missing intervals
- Holes with duplicate collar co-ordinates (i.e. same hole with different names)
- Missing dip / azimuth
- Holes missing assays
- Holes missing geology

The modelled wireframes were used to create a block model. The Panel OK estimate for gold for each domain was implemented in Isatis using the search neighbourhood parameters defined by QKNA analysis. The Panel block estimation size used was 8mX x 16mY x 10mZ. The OK search and variogram rotations were varied locally using a set of guiding surfaces to best mimic the interpreted orientation of the lodes. The final LUC model, after post-processing steps have been applied has a user block 4mE by 8mN by 2.5mRL which relates to an SMU in order to reflect the current mining selectivity.

The parent block size was selected on the basis of being approximately 50% of the closest drill hole spacing in the deposit (excluding the grade control 5m by 5m grid data).

The search ellipse used were based on the ranges of continuity observed in the variograms along with considerations of the drillhole spacing and lode geometry. The search ellipse was rotated to best reflect the lode geometry and the geology as seen in the drilling and as described in the logging. This geometry was checked to ensure that it was also supported by the variogram analysis.

Topcuts were determined from statistical analysis. A number of factors were taken into consideration when determining the top-cuts including:

- The disintegration point of the data on the probability plots;
- Having a coefficient of variance (CV) under 2.0; and
- Reviewing the model (block) grades against the composites.

Distance limiting above a specified grade threshold was applied to the Panel estimate in the LUC workflow, in order to inhibit the propagation of high-grade composites in the estimation. The distance limiting thresholds were picked by identifying inflexions in the gold grade distribution and distance limits were based largely on the practical range of the relevant gold grade variograms.

A range of criteria were considered when addressing the suitability of the classification boundaries to the resource estimate.

- Geological continuity and volume models;
- Drill spacing and available mining information;
 - Indicated - drilling (25mx25)
- Modelling technique
- Estimation properties including search strategy, number of informing composites, average distance of composites from blocks, number of drill holes used and kriging quality parameters.

- The classification for this model was predominantly based on the slope of regression (SOR) which is a measure of the quality of the estimate.
 - SOR greater than 0.6
- The classification of the blocks was also visually checked and adjusted to remove any “spotted dog” effects. No measured resources were calculated.

Bulk densities were assigned as 1.85 t/m³ for oxide, 2.25 t/m³ for transitional material in the Mafic, 2.55 t/m³ for transitional material in the Granite, 2.73 t/m³ for fresh material in the Mafic, 2.75 t/m³ for fresh material in the Granite

The Williamson open pit has been reported with a 0.5g/t bottom cut within the \$2,400 pit shell for oxide, transitional and fresh material.

Ore Reserve Estimate

Ore Reserve Commentary

All Wiluna Ore Reserves have been reported from measured and indicated resources only. Measured and indicated resources were converted to proved and probable ore reserves based on modifying factors, mine designs and economic evaluation. Open pit reserves have been generated from internal optimisations and open pit designs using appropriate operational costs, geotechnical, dilution, recovery and cut-off grade parameters.

Current operational pits at the Matilda mining centre have been depleted for mining to 30th June 2019. During 2018-2019, Blackham completed mining at M1 South, M2, M5 pits at Matilda, with partial depletion of M1 North, East-West, Essex, Happy Jack and GAN pits at Matilda and Wiluna mining centres. At Williamson, an update to the LUC resource model resulted in a revised conservative pit design and reduced reserve estimate prior to mining. Open pit ore reserves were completed by Blackham’s Principal Planning Engineer.

Ore reserve estimations for the Golden Age underground mine at the Wiluna mining centre was completed by Blackham Resources Ltd. Current underground operations at Golden Age were depleted and updated in line with the company’s rolling ore reserve replacement strategy. Ore reserves for the Bulletin, Creek Shear, Essex and East-West underground mines at the Wiluna mining centre were completed by Entech Pty Ltd (Entech).

The Wiluna open pit and underground reserves are based on the Wiluna Expansion Preliminary Feasibility Study (PFS) announced to the market on the 30 August 2017, “Expansion PFS shows robust economics for a 200koz pa long life”. Open pit reserves have been updated for mining depletion until 30th June 2019. Wiluna underground and Wiltails reserves have not changed since the last update - see ASX release dated 31st October 2018, “Blackham gold reserves grow 27%”.

Mining studies are well advanced for Blackham’s transition to Stage 1 of its Sulphide Expansion Project, and a significant Reserve update is anticipated at the completion of this work, expected in the December ’19 quarter.

Open Pits

Production at the Matilda pits is expected to conclude with the completion of M1 North in the December ’19 quarter, and production at the Wiluna free-milling pits is expected to conclude with the completion of Happy Jack North, Essex and Bulletin pits also in the December ’19 quarter. Mining at Williamson has commenced, and Williamson will provide base load mill feed at the Wiluna Gold Project throughout 2020, with a lesser component

of free-milling ore from Golden Age underground. The remaining reserve is focused on the Wiluna Sulphide Expansion.

Reserve updates to the open pits relative to the 2017 PFS are outlined below:

- All open pit reserves now estimated using a gold price of \$2,000/oz.
- Use of updated mineral resource estimates to calculate in-situ reserves.
- Pit designs were retained from the 2018 MRRE optimisations, which were based on a \$1,650/oz Au price. Under the increased commodity price as at 30 June 2019, this allows a conservative view of the pit designs that offsets any potential upward changes in other economic factors.
- The Williamson pit design was based on a \$1,800/oz Au price optimisation and updated mining costs provided by the mining contractor.
- Cut-off grades for reporting ore and waste components within the designs were calculated based on the \$2,000/oz price.
- In East-West pits, components of inferred material have been used to determine the final pit design (based on local high confidence of conversion) however only measured and indicated material is reported in the reserves.
- In Bulletin pit, inferred resources located on the margins of existing underground-mined voids has been re-classified to indicated and probable reserves, based on a revised mining plan to ensure safe and efficient extraction with an allowance for increased mining dilution and reduced mining recovery. This indicated material has been included in the calculation of the reserves.
- Any inferred material contained within the mine plan has been treated as waste. The ore reserves have been defined at delivery to the processing plant ROM pad.




Figure 2: Wiluna free-milling pit designs as at 30th June 2019 in orange, and Expansion Sulphide Pits in green stretching over 3.9kms of strike next to the Wiluna Gold Plant.

The main variances between the 2019 and 2018 reserves are:

- Matilda (**-0.9Mt, -49koz**) due to completion of mining at M1S, M2 and M5, and depletion of M1N. Review of M6 for the 2019 reserves has determined that the basis of classification for this deposit is below that required to declare it a reserve (with further drilling and modelling to be undertaken) and hence it is removed from 2019 reporting.
- Williamson (**+0.1Mt, -14koz**) resulting from a re-optimisation and re-design based on an updated LUC-based resource.
- Wiluna (**-0.8Mt, -74koz**) due to mining depletion during 2018-2019 from interim pits at East-West, Essex and Happy Jack, and completion of mining of Golden Age North pit.
- Overall (**-1.6Mt, -139koz**) change is due to mining depletion and resource re-classification.

Additions to the reserves due to downward changes in cut-off grade have, in instances of re-optimisation such as Williamson, been offset by rising mining costs. In other contributors, such as the Wiluna sulphide expansion, downward changes in cut-off grade have not been accompanied by a significant increase in fresh (sulphide)

ore; some of this is due to changes in resource models in both re-estimation and re-classification of ore, including revisions to some weathering surface boundaries.

As stated previously, a major reserve update is anticipated during the December '19 quarter, reflecting updated resource models in progress, and mine optimisation studies for underground and open pits.
