Issue of Shares under Director Fee Plan

Proteomics International Laboratories Ltd (Proteomics International; ASX: PIQ) advises that the Company has issued 110,770 fully paid ordinary shares (**Shares**) to non-executive director, Mr Paul House.

The Shares were issued under the Director Fee Plan in lieu of director's fees owed to Mr House for the period from 1 October 2018 to 30 September 2019. Shareholder approval was obtained for the issue of Shares to Mr House at the Annual General Meeting held on 22 November 2018.
