WestStar business SIMPEC Wins \$5M Contract for Tianqi Lithium **Kwinana Plant**

Highlights

- WestStar business SIMPEC Pty Ltd has been awarded a ~\$5M contract at the Tianqi Lithium processing plant at Kwinana in Western Australia
- ~\$23M in contracts awarded to WestStar in the first 4 months of FY2020
- The award by Tianqi Lithium Kwinana ("TLK") follows on from SIMPEC's current work at the Tianqi Lithium Processing plant in Kwinana
- Under the new contract, SIMPEC will supply SMP and E&I completions and commissioning support services for the stage 1 processing plant.
