### Re: Issue of Securities

Oilex Ltd (Oilex or the Company) advises that it has issued 118,421,053 shares in regard to the £600,000 equity capital raising announced on 30 September 2019. The Company has also issued 29,457,413 shares to complete the acquisition of a 79.3333% participating interest in Cooper-Eromanga Basins PEL 112 and 444 (PELs) as announced on 7 September and 14 September 2019.

Specifically, the share issue comprises the following:

- 118,421,053 ordinary shares at 0.19 pence per share pursuant to the £600,000 equity capital raising announced on 30 September 2019. The share issue comprises 67,270,293 shares issued under Listing Rule 7.1 and 51,150,760 shares issued under Listing Rule 7.1A;
- 16,166,767 ordinary shares at A\$0.003 per share pursuant to the second and final tranche relating to the acquisition of a 48.0003% beneficial interest in the PELs as announced on 7 August 2019. The shares have been issued under Listing Rule 7.3 and were approved by shareholders on 19 September 2019; and
- 13,290,646 ordinary shares at 0.19 pence per share pursuant to the second and final tranche relating to the acquisition of a 30.8330% beneficial interest in the PELs as announced on 14 August 2019. The shares have been issued under Listing Rule 7.1. The parties have agreed to issue the shares in lieu of the final cash consideration payable of A\$46,249.50.

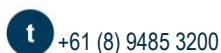
The applicable Appendix 3B for the issue of the abovementioned securities is attached. The issue of the remaining 197,368,421 shares in regard to the £600,000 equity capital raising is anticipated to occur later in the month.

### AIM Admission and Total Voting Rights

Application has been made to the London Stock Exchange plc for the admission of the 147,878,466 new shares (Shares) to trading on AIM (Admission). Admission of the Shares is expected to become effective and dealings to commence at 8.00 a.m. on 21 October 2019. Following Admission of these shares, the Company will have 3,025,942,949 shares in issue. The Company does not currently hold any shares in treasury. Accordingly, the total number of voting rights will be 3,025,942,949.
