### Highlights

- **Winchester has re-entered the Thomas Ranch #2 well (100% working interest) and is currently drilling out the plugs.**
- **Targeting potential Cisco Sands as identified in logs from the nearby Thomas 119-1H well.**
- **The significant Lightning Prospect discovery well, Arledge 16#2, 5 miles to the south, has produced oil from the Cisco Sands.**

### Thomas Ranch #2 (Winchester - 100% Working Interest and Operator)

Winchester Energy Limited (Winchester) has initiated operations on the Thomas Ranch lease by re-entering and drilling out plugs at the Thomas Ranch #2 well located 2,953 feet south south-east from the surface location of the Thomas Ranch 119-1H well.

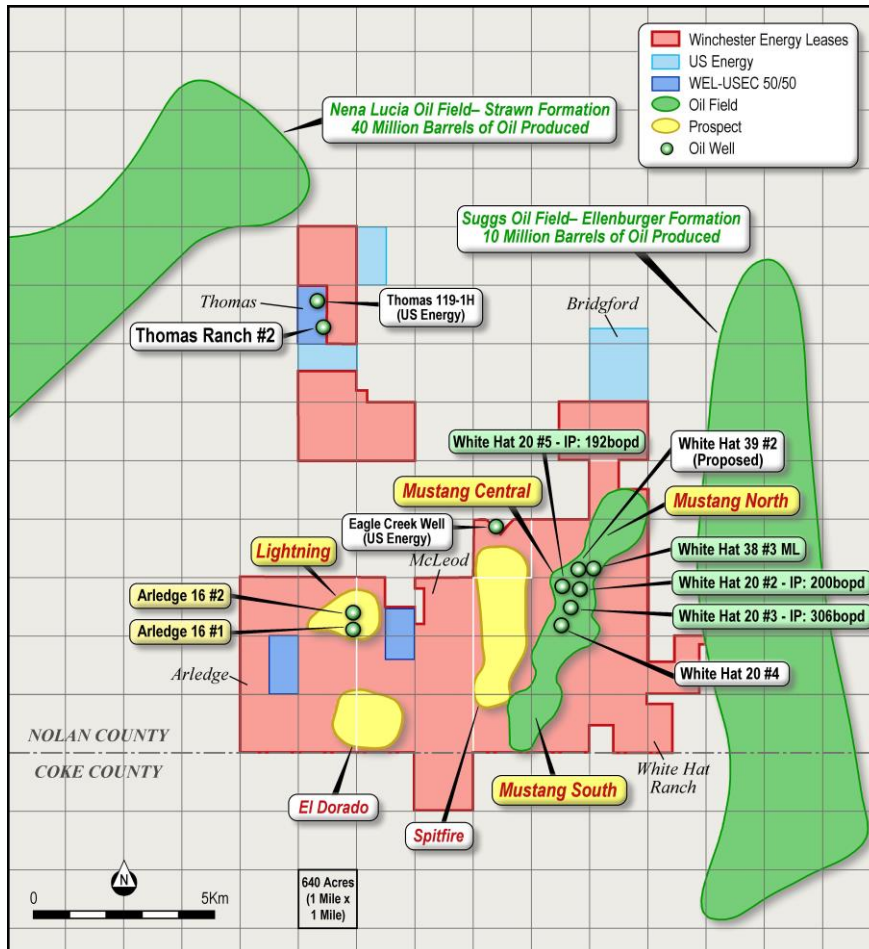
Based on log analysis on the Thomas Ranch 119-1H vertical hole logs, Winchester has identified potential Cisco Sands similar to that encountered in the recent Arledge 16#2 discovery well at the Lightning Prospect.

Winchester plans to re-enter the well to a depth of 5,000 feet and run logs to test the potential Cisco Sand interval at 4,900 feet. If unable to reach 5,000 feet the company will evaluate a prospective shallow sand unit at approximately 1,500 feet also identified in logs derived from the vertical component of Thomas 119-1H.
