Request for trading halt: Dropsuite Limited (ASX: DSE)

Dropsuite Limited (ASX: DSE) (**Dropsuite** or **the Company**) requests a trading halt to be applied to our securities under ASX Listing Rule 17.1 from as soon as received on Friday 18 October 2019 and as set out below details of the request as per the rules of ASX.

The trading halt is requested in connection with follow-up queries raised by the ASX in relation to today's announcement, New Partnership with Major Hosting Provider 1&1 IONOS. The following information is provided in accordance with Listing Rule 17.1:

- 1. Reasons for trading halt to avoid trading taking place on an uninformed basis.
- 2. **Duration of the trading halt** the Company expects the trading halt trading halt remain in place until the earlier of the release of an announcement by the Company or the commencement of trading on Tuesday, 22 October 2019.
- 3. **Termination of the trading halt** the Company anticipates the trading halt will cease no later than upon the commencement of trading on Tuesday, 22 October 2019.
- 4. **No reason** the Company is not aware of any reason for why the trading halt should not be granted.
