Issue of Securities and Notice Under Section 708A

Rumble Resources Limited (Company) (ASX: RTR) hereby notifies the ASX under section 708A(5)(e) of the Corporations Act 2001 ("the Act") that the Company has issued on 18 October 2019 3,846,153 fully paid ordinary shares ("Shares") to Zenith Minerals Limited in respect of the acquisition of 75% of the Earahedy Project, under its existing placement capacity under ASX Listing Rule 7.1.
