

Talga and BillerudKorsnäs Sign Graphene Joint Development Agreement

Advanced battery anode materials and graphene additives provider Talga Resources Ltd ("Talga" or "the Company") (ASX:TLG) is pleased to advise it has executed a Joint Development Agreement ("JDA") with BillerudKorsnäs, a Swedish based multinational packaging company.

The JDA results from successful testwork completed under the Letter of Intent ("LoI"), signed by the parties in August last year (ASX:TLG 23 Aug 2018), regarding Talga's functionalised graphene product, Talphene®, used in BillerudKorsnäs fibre and board packaging products.

Terms of the JDA set forth a structure for the parties to continue development of the packaging technology. Highlights of the JDA include:

- Ongoing co-development and validation of improved packaging technology incorporating Talphene in BillerudKorsnäs products.
- Terms for potential commercialisation of products and intellectual property ownership.
- Commercialisation of successful products can be facilitated through BillerudKorsnäs' existing global industrial clients.

The incorporation of Talphene into BillerudKorsnäs packaging is designed to enable a range of performance and eco-benefits such as natural fibre replacement of plastic packaging, amongst others.

We are excited to be advancing our relationship with a global industry leader such as BillerudKorsnäs to enable greener and innovative packaging solutions with our graphene technology."
