Explanatory notes to Appendix 4C

- FE Investments Limited ("FEI") is a Non-Bank Deposit Taker in New Zealand with its deposit taking licence issued by Reserve Bank of New Zealand. Under its accounting policy, FEI's operating cashflow includes deposits accepted from the New Zealand public, loans made to borrowers, interest earned on loans and interest paid to depositors.
- FEI is a wholly owned subsidiary of FE Investments Group Limited. More information about FEI
 and its operations can be obtained at www.fei.co.nz

Income

- Income from business leasing is shown in item 1.1. This represents finance lease payments received in the quarter.
- Interest earned on business loans is shown in item 1.4. The companies' earnings also include capitalised revenue which is *not* shown in the 4C, as it is a non-cash item.

Term Deposits

- Interest paid on term deposits held is shown in item 1.5. During the quarter FEI raised approximately A\$12.0m (including reinvestments) in term deposits, which was the appropriate offset to our lending growth.
- The net movement between cash raised through term deposits and cash outflows from business loans written is shown in item 1.8. The negative cashflow in the quarter is a positive result for FEI as a lending company as it shows growth in our loan book.

Other

- Administration and Corporate Costs (1.2.f) for this quarter includes one-time set up costs for new corporate financing facilities.
- The closing cash balance as at 30 September 2019 is shown in item 5.5.
- The Cash outflows for the next quarter Item 9 is explained further below:
 - 9.3 Relates to both Australian and New Zealand advertising for loans & deposits for the next quarter.
 - 9.5 Staff costs include both countries payroll, with expected staff movement and new commercial staff additions.
 - 9.6 includes the Accounts Payable on the loan book as at 30 September 2019 plus additional expected administrative and corporate costs for the upcoming quarter – some of which will be one-off expenses.
 - 9.7 relates to the expected cash outflow for further business development in Australia, which can include capital expenses e.g. technology upgrades, website upgrades, new equipment's etc.
- The Company has used an exchange rate of AUD\$1.00 to NZD\$1.0768 as at 30 September 2019 in relation to the cash amounts held by FEI.
