Notice under Section 708A of the Corporations Act

This notice is given by ParaZero Limited (Issuer or Company) (ASX:PRZ) under section 708A(5)(e) of the Corporations Act 2001 ("Act").

The Issuer has today issued 10,219,999 Ordinary Fully Paid Shares at an issue price of \$0.06 per share (the Securities) in accordance with the terms of the placement announcement to the market on 24 October 2019.

1. the Issued Shares were issued without disclosure to investors under Part 6D.2 of the Act;
