MASTER DISTRIBUTION AGREEMENT WITH ALIBABA CIP NEW BRAND LAUNCH FOR ADULT GOAT DAIRY RANGE

- New brand 'Deloraine' to tap into RMB 10bn (AUD 2bn) China goat dairy market.
- Master Distribution Agreement with Alibaba CIP to import adult goat dairy products for mainland China.
- Agreement sales volume worth RMB50m (AUD 10m) in first year.
- Access to 700 million active users on Alibaba platforms through Alibaba's Centralised Import Procurement (CIP) initiative.
- Appointed key distributor 'The Land' to supply eCommerce and General Trade channels.

Shanghai, 6 November 2019: Bubs Australia (ASX: BUB) today has announced a strategic agreement with Alibaba CIP to capitalise on the growth of China's RMB10bn / AUD 2b goat dairy market including the launch of new brand 'Deloraine,' which will be produced at the Bubs Australia manufacturing hub, Australia Deloraine Dairy in Victoria. Under the Agreement, Bubs Australia and key channel partner, Alibaba CIP expect to ship adult goat dairy products, including CapriLac® and Deloraine® brand portfolios, worth RMB 50m (AUD 10m) in Year 1.

The announcement coincides with the signing today of a Master Distribution Agreement between Bubs Australia and Alibaba Centralised Import Procurement (CIP) during an official ceremony at the China International Import Expo (CIIE) in Shanghai. Alibaba CIP and their appointed distributor, The Land, will be responsible for promoting and distributing the adult goat dairy range across the entire Alibaba online and offline ecosystem, as well as other external General Trade and Cross-border eCommerce channels.

Announcing the Agreement, Bubs Founder and CEO Mrs. Kristy Carr said: "This collaboration with Alibaba CIP is a very meaningful and exciting development for Bubs. There is a huge and growing market for premium adult goat-based dairy products. Now, with the experience of marketing our current adult product, Caprilac® we are confident in launching an expanded Deloraine® adult goat dairy range in conjunction with Alibaba CIP that will cater to the premium end of the segment with science based functional benefits, including being a high source of calcium, containing naturally A2 goat protein, EGF (Epidermal Growth Factor), and Tryptophan - which aids sleep.

"Clearly the Alibaba CIP program and related platforms have unique reach into the China adult nutrition market – some 700 million active users. At the same time, we are the only Australian vertically integrated producer of goat milk formula and so are uniquely positioned to offer Alibaba's platform-wide customers the comfort that we have complete control of the supply chain right back to the farm gate," said Mrs Carr.

Dennis Lin, Executive Chairman of Bubs said: "It has long been a privilege to work in partnership with Alibaba across our infant nutrition products, and the opportunity to now develop the market for our adult goat dairy range through this Master Distribution Agreement is another step in the growing acceptance of the maturity of our business."
