Erik Opstad Biography

Mr. Erik Opstad has 40 years of energy project management and technical experience including with BP in Alaska, conducting both offshore and onshore operations. In 2000 Mr. Opstad founded ELKO International LLC (ELKO), which has been providing oilfield services to a wide spectrum of domestic and international clients continuously since that time.

ELKO Focused Activities

- drilling management and engineering;
- well completions;
- plugging and abandonment program design & operations;
- restoration and remediation of drill sites;

In 2008 ELKO and partners purchased the Badami Field and Pipeline from BP Exploration (Alaska) Inc. Following that acquisition Mr. Opstad served as Drilling & Wells and General Manager of the new company Savant Alaska, driving geoscience and engineering redevelopment activities in the Badami oilfield on the North Slope of Alaska. After selling the Badami field to Miller Energy in 2014, Erik and ELKO assisted 88 Energy Ltd, in a series of North Slope exploration projects, then recently formed Jade Energy LLC to develop Jade's Brookian age oil resources within the Point Thomson Unit.
