## **RESULTS OF ANNUAL GENERAL MEETING**

The Directors are pleased to advise in accordance with ASX Listing Rule 3.13.2 and Section 251AA of the Corporations Act, details of the resolutions and proxies received for the Annual General Meeting held on 15 November 2019.

Following consultation with key stakeholders and Mr Kris, Resolution 5 was withdrawn and accordingly not put to shareholders. As announced on 11 November 2019, the Company has secured new funding from Pure Asset Management and once this funding is finalised the remaining three tranches of convertible notes under the L1/Lind facility will be cancelled. Accordingly Resolution 10 was also withdrawn and not put to shareholders.
