# **Annual General Meeting Results**

**AVZ Minerals Limited** (ASX: AVZ) is pleased to confirm that at today's Annual General Meeting all resolutions contained in the Notice of Meeting were passed on a show of hands.

In accordance with section 251AA of the Corporations Act 2001 and ASX Listing Rule 3.13.2, the following information is provided to ASX:

#### Resolution 1: Adoption of Remuneration Report

The total number of proxy votes exercisable by proxies validly appointed was 262,025,097. The resolution was decided by a show of hands. A breakdown of the proxies is as follows:

The resolution was carried as an ordinary resolution. As more than 25% of the votes were cast against this resolution, this constitutes a first strike for the purposes of the Corporations Act (Cth).
