PEPPERMINT FUNDING UPDATE

Peppermint Innovation Limited (Peppermint or the Company) is pleased to provide an update on funding of the Company.

First Closing of a Placement:

12,500,000 ordinary shares have been issued to sophisticated and professional investors at \$0.01 per share to raise \$125,000 before costs.

This is the first closing of a \$1,500,000 / 150,000,000 ordinary share placement at \$0.01 cent per share which Peppermint is seeking to close.

Conversion of \$150,000 Convertible Note:

\$150,000 of convertible notes and accrued interest have been converted into 16,422,00 fully paid ordinary shares at \$0.01 per share.

Extension of the Maturity Date of \$1.5m Convertible Note:

The maturity date of \$1,500,000 of convertible notes has been extended from 30 April 2020 to 30 April 2021 in consideration for the issue of 35,000,000 unlisted options to acquire ordinary shares at \$0.01 per ordinary share on or before 30 May 2021.
