Bubs Australia Limited (Bubs) gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (the Corporations Act) that:

- 1. Bubs has today issued 31,578,947 fully paid ordinary shares under a placement (Placement) without disclosure to investors under Part 6D.2 of the Corporations Act. The Placement shares were issued at an issue price of A\$0.95 per share. The Placement will raise approximately A\$30 million (before costs).
- 2. As at the date of this notice:
 - (a) Bubs has complied with the provisions of Chapter 2M of the Corporations Act as they apply to Bubs;
 - (b) Bubs has complied with section 674 of the Corporations Act; and
