Aeromagnetic Survey Planned at Bonanza Gold Project

Highlights:

- A detailed aeromagnetic survey is planned at the Bonanza Gold Project adjacent to Spectrum Metals Penny West Gold Mine at Youanmi.
- > Survey will target structures that potentially could host gold mineralization to the west of the Penny West Mine.
- Consultant geologist Nick Revell has been appointed to assist with the exploration.




Figure 1: Location plan showing planned aeromagnetic survey area



Sabre Resources Limited (**Company** and **Sabre**) is pleased to announce it has engaged a geophysical contractor to undertake a detailed aeromagnetic survey on Exploration License Application ELA57/1125 (Bonanza Project) located immediately west of the Spectrum Metals Penny West Mine. The magnetic survey will be conducted over an area of 2km by 3km in the northeast corner of ELA57/1125 with a line spacing of 10m-20m for a total of 350 line kilometers (Figure 1).

Once the data has been acquired it will be processed, imaged and interpreted by Southern Geoscience Consultants with the aim of locating structures and lithological units that may host gold within the greenstone-granite sequence. The Penny West North gold discovery is located on the north-south trending Youanmi Shear Zone. Fault splays extend off the Youanmi Shear to the northwest along the greenstone boundary.

Sabre's exploration on the Bonanza Project will be assisted by consultant geologist Nick Revell who has extensive experience in precious metal exploration in the West Australian Goldfields.

Background

In August 2019, Sabre announced that it had entered into a binding Share Sale Agreement to acquire Power Metals Pty Ltd, the holder of a 100% interest in Exploration License Application ELA57/1125 (Bonanza Project). The Company commenced technical and legal due diligence on Power Metals Pty Ltd. Aquisition was subject to shareholder approval, which was received on 30 October 2019. The grant of ELA57/1125 to Power Metals Pty Ltd is currently still pending.
