

COMPLETION OF AUSTRALIAN INSTITUTIONAL PLACEMENT

Salt Lake Potash Limited (SO4 or Company) is pleased to advise that it has completed the previously announced placement to a number of new Australian institutional investors and existing institutional shareholders to raise A\$23.0 million for the ongoing development of the Lake Way Project (Project).

The Placement of approximately 32.9 million shares at A\$0.70 each to raise A\$23.0 million before costs (Placement), further strengthens SO4's share register with strong demand from a number of new and existing institutional investors.

Placement funds will contribute to the continued rapid development of the Lake Way Project, including construction of Stage 2 on-lake infrastructure and commencement of site works for the process plant in early 2020, along with ongoing exploration of other lakes and general working capital.

The Institutional Placement, comprising 32,867,858 shares completed today. An additional 703,571 shares that Directors intend to subscribe for will be issued subject to shareholder approval. This includes 428,571 shares by the CEO, Mr Tony Swiericzuk, and 275,000 shares by the Company's Chairman, Mr Ian Middlemas. A notice of meeting will be sent to shareholders shortly.
