**Bubs Australia Limited (ASX: BUB)  
Notification under section 708A(5)(e) of the Corporations Act 2001 (Cth)**

Bubs Australia Limited (Bubs) gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (the Corporations Act) that:

1. Bubs has today issued 5,263,158 fully paid ordinary shares under a share purchase plan (**SPP**) without disclosure to investors under Part 6D.2 of the Corporations Act. The SPP shares were issued at an issue price of A\$0.95 per share. The SPP has raised A\$5 million (before costs).
2. As at the date of this notice:
  - (a) Bubs has complied with the provisions of Chapter 2M of the Corporations Act as they apply to Bubs;
  - (b) Bubs has complied with section 674 of the Corporations Act; and
  - (c) there is no "excluded information" within the meaning of sections 708A(7) and 708A(8) of the Corporations Act which is required to be disclosed under section 708A(6)(e) of the Corporations Act.708
