Results of Scheme Meeting

Pensana Metals Limited (ASX: PM8) (**Pensana** or the **Company**) is pleased to announce that Pensana shareholders today approved, by the requisite majorities, the scheme of arrangement by which Pensana Rare Earths plc (**Pensana UK**) will, subject to the satisfaction or waiver of certain conditions, acquire all of the ordinary shares in Pensana (**Scheme**).

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), a detailed report of the votes cast in respect to the resolution approving the Scheme is included as Appendix 1 to this announcement.

Although Pensana shareholder approval has been obtained, the Scheme remains subject to a number of conditions as set out in the Scheme Implementation Agreement (a full copy of which is disclosed within the scheme booklet, which is available on the ASX website at www.asx.com.au and on Pensana's website at www.pensanametals.com), including:

- the Supreme Court of Western Australia approving the Scheme (Second Court Hearing);
- the ASX approving the admission of Pensana UK to the official list of the ASX and the Pensana UK CDIs for official quotation;
- the independent expert continuing to conclude that the Scheme is in the best interests of shareholders; and
- the satisfaction or waiver of any remaining conditions prior to the Second Court Hearing.

Subject to these remaining conditions being satisfied or waived, implementation of the transaction is expected to occur in early February 2020 (see indicative timetable below).

The Second Court Hearing will be held at 10:00am (WST) on Wednesday, 15 January 2020 at the Supreme Court of Western Australia at 28 Barrack Street, Perth, Western Australia. Further details regarding the Second Court Hearing are included as Appendix 2 to this announcement.
