Answer: Yes, current level of spending is expected to continue until the BFS and Environmental Assessment work is completed.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes. In June 2018, the company entered into an Investment Agreement and a Shareholders' Agreement with Bathurst Resources Ltd (**BRL**) to provide funding to advance the Crown Mountain project. In accordance with the terms of the Investment Agreement, BRL provides funding to the operations earning BRL 50% interest in the Crown Mountain project upon meeting its entire obligation of C\$121.5 million (ongoing payments are at BRL's option).

Tranche One Option was completed during the quarter with receipt of A\$1.2m. Advance payment totalling A\$1.3m towards Tranche Two Option has been received during the quarter with A\$556K (C\$500K) being received post quarter (not included in 3.2.1 or 3.2.2 above).
