STATEMENT OF CONFIRMATIONS

Corizon Limited (ACN 142 411 390 (to be renamed 'eMetals Limited') (Company) confirms that all conditions precedent to the public offer (Public Offer) and priority offer (Priority Offer) (together, Offers) under the Company's replacement prospectus dated 5 November 2019 (Prospectus) have been satisfied.
