TRANSCENDENCE TECHNOLOGIES LIMITED DECEMBER 2019 QUARTERLY ACTIVITIES REPORT

The Board of Transcendence Technologies Limited (**TTL** or the **Company**) provides the following report on its activities for the quarter ended 31 December 2019.

The Company remains suspended from official quotation in accordance with Listing Rule 17.3, after ASX determined that TTL's operations are not adequate to warrant the continued quotation of its securities pursuant to ASX Listing Rule 12.1. The suspension will continue until the Company is able to demonstrate compliance with Listing Rule 12.1.

The Board continues to proactively identify and review acquisition and investment opportunities. In the meantime, the Board has implemented a cost reduction programme in order to conserve cash. The Company's directors, as well as its corporate advisor, have reduced their fees by 50%. Corporate secretarial and financial management service fees have been reduced by 25%, and the Company has terminated all non-essential services and consultancy contracts.

At the end of the quarter, the Company had cash reserves of approximately \$0.889 million. The Appendix 4C report attached to this report contains the Company's cash flow statement for the quarter.
