### **Receipt of Request to call General Meeting of Shareholders**

Accelerate Resources Limited ("Accelerate" or "the Company") notes that on 22<sup>nd</sup> of January, 2020 it received a notice under section 249D of the *Corporations Act 2001* (Cth) ("Notice") signed by GTT Global Opportunities Pty Ltd, Mounts Bay Investments Pty Ltd, Syracuse Capital Pty Ltd, Murdoch Capital Pty Ltd and Kcirtap Securities Pty Ltd, requisitioning a general meeting of the Company to consider resolutions for the election of Mr Charles Thomas and Mr David Sanders as Directors of the Board, and the removal of Managing Director Ms Yaxi Zhan and Non-Executive Director Mr Terry Topping from the Board ("Proposed Resolutions").

This is the third such action by the same group of shareholders which is disruptive and costly to the Company. Such behavior will not be supported by shareholders, and the Company will seek legal advice. As such, the Board disagrees with the Proposed Resolutions and recommends shareholders vote **AGAINST** on all Proposed Resolutions.

The Company will call a meeting of shareholders to be held within 2 months of receipt of the Notice in accordance with the requirements of the Corporations Act. A copy of the Notice is attached to this announcement. In the meantime, the Board will continue to focus on the Tambellup Kaolin Project and the creation of value for shareholders through project development.
