3. Joint and Several Voluntary Administrators were appointed to the Company on 10 October 2018;
4. The then sitting full board resigned on 10 October 2018;
5. It was announced on 18 October 2018 that Wolf Minerals (UK) Limited was ordered to be wound up under the provisions of the *UK Insolvency Act 1986*;
6. The then sitting company secretary resigned on 1 November 2018;
7. The Joint and Several Voluntary Administrators announced on 11 November 2019 that all requirements of the Deed of Company Arrangement (“**DOCA**”) had been completed as at 11 November 2019 and the DOCA was wholly effectuated;
8. New board members and company secretary were appointed to the Company on 11 November 2019;
9. The current board took over the Company from 11 November 2019;
10. The current board tried to request company information and financial information from the previous Joint and Several Voluntary Administrators as well as the previous board members, and received very limited information; and
11. The attached Appendix 4G was prepared to the best knowledge of the current board.
