# Providing access to 1.5m member workers

Vection Technologies Ltd (ASX:VR1) (Vection or the Company), a multinational software company that creates **3D**, Virtual Reality (VR) and Augmented Reality (AR) solutions, is pleased to announce the commercialisation of FrameS Training to the Italian General Confederation of Independent Trade Unions (GCITU).

The GCITU is an Italian autonomous trade union confederation with 1.5 million members<sup>1</sup>, representing workers active in both the public and private sectors including the health, education, agriculture, banking, television, postal and transport sectors.

# FrameS Training: GCITU

During the 2020 calendar year, the GCITU plans to roll-out a comprehensive catalogue of immersive Virtual Reality training and induction courses for its members. As part of this strategic vision, the GCITU is initially targeting the agricultural sector, via an initial subset of VR safety training modules.

The GCITU plans to establish a first classroom equipped with 10 Virtual Reality workstations where its members can participate in its FrameS Training software courses.

The virtual reality classroom is a self-contained space equipped with state-of-the-art hardware and FrameS Training software required to deliver ultra-realistic virtual reality experiences, allowing workers to move with a fair degree of freedom, closely replicating a real-world worksite experience.



This initial engagement to deliver VR hardware and FrameS Training software modules, will generate  $^{2}$  \$130,000 in short-term revenue for Vection<sup>2</sup>.

Additional modules addressing the training and induction requirements for further market segments and work functions will be developed on an ongoing basis with the GCITU following this initial engagement.

# **FrameS Training: Overview**

FrameS Training is an educational tool which provides workers with immersive Virtual Reality based worksite inductions and reduces injuries related to unsafe situations and man/machine interactions.

FrameS Training represents the best-in-class training tool for the GCITU, bridging the gap between theory and competency for workers with locations dispersed nation-wide.

FrameS Training ensures workers' competency, providing:

- Familiarisation and understanding of machinery and equipment prior to real-life use, providing an operational foundation to the worker
- Real-time feedback to the instructors, highlighting potential issues prior to real-life evaluation, thus
  reducing risk of injuries
- Immersive Virtual Reality training and induction result in more effective learning outcomes:
  - o Real-life-like sensations and feelings
  - o Accurate muscle memory development
